

Council Hearings & Resolutions

Delivery Commission Fees

Councilors Michael Flaherty, Matt O'Malley & I recently held a hearing regarding the impact of 3rd party delivery commission fees on Boston's restaurant industry during this crisis. As local restaurants have become heavily reliant on delivery, many are concerned about their ability to survive with 30% fees. I discussed my desire to place a cap on these fees like other cities across the country. I look forward to an upcoming working session on this issue. Hearing on Language Access

I was proud to join Councilor Mejia as a co-sponsor on our hearing on language access, cultural competency, and ways to holistically communicate with our diverse communities. This hearing was conducted in Spanish, Mandarin, Cantonese, and Haitian-Creole, the first hearing to do so in the City Council.



Memorial Day Resolution

I filed this resolution to commemorate and honor our veterans, military Gold Star families of those who made the supreme sacrifice in service to our country. It is important that we recognize that their sacrifice, service, and their bravery shall never be forgotten.

Resolution Supporting Our Chinese and Asian American Communities During the COVID-19 Pandemic

Due to the virus, there are unfortunately many reports of racism and discrimination against Chinese and Asian communities in the United States and around the world. This resolution affirmed the Council's support for the Chinese and Asian communities during this time. Moreover, we recommit the City Council in standing up against any form of racism.

City Budget and Community Preservation Funds

We are in the midst of our budget season in the City Council, where we are conducting budget hearings for every City department to understand their needs, and advocate for budget items in our community. There will be a hearing specifically for public testimony on the city budget on Thursday, May 28th, 6pm. More information about that hearing is here: https://www.boston.gov/public-notices/11565441

We also voted to pass the latest round projects fund

We also voted to pass the latest round projects funded by the Community Preservation Act (CPA). The CPA provides funding for initiatives related to affordable housing, historic preservation, open space, and outdoor recreation facilities. This year, the CPA funding includes the following D2 projects:

- South Boston Barnard Place Park for open space, \$150,000
- South Boston Kearsarge Anchor in Marine Park for historic preservation, \$75,000
- Beacon Hill Rogerson-Faneuil Apartments for historic preservation, \$340,000
- Chinatown Chinatown Backyard for open space, \$500,000
- Chinatown Parcel 12C for affordable housing, \$1,000,000
- West End Greater Boston Legal Services building for historic preservation, \$100,00

Reopening Massachusetts

Last week, Governor Baker announced the plan to reopen the Massachusetts economy in phases, with all businesses required to follow guidance on physical distancing, as well as mandatory standards on workplace safety and sector-specific protocols.

A Safer At Home Advisory is in place asking residents to continue to stay at home if possible, and only leave home for healthcare, worship and permitted work, shopping, and outdoor activities. Face covering is still REQUIRED when residents cannot maintain six feet of physical distance in public. All business activities when they reopen must follow guidance on physical distancing, hygiene protocols to prevent COVID-19, and have plans in place for staffing and operations in case employees get sick. Moreover, the Governor has issued sector-specific protocols and best practices for businesses to reopen safely. There will be four phases to the Governor's reopening plan, and the first phase started on May 18th, with certain businesses being allowed to resume with restrictions, some capacity limitations, and staggered starts.

On May 18th, the following businesses were eligible to start:

- Essential businesses can stay open and continue to operate
- Manufacturing
- Construction; however, Boston will reopen its construction sites in phases, and will expand permitted construction incrementally. More information is here: https://www.boston.gov/news/temporary-guidance-construction-city-boston#allowed-construction-work
- Worship
- Hospitals and community health centers who attest to specific public health/safety standard can provide high priority preventative care, pediatric care and treatment for high risk patients

On May 25th, the following businesses were eligible to start:

- Laboratory and life sciences facilities
- Offices, excluding those in the City of Boston. Work from home strongly encouraged, and businesses should restrict workforce presence to <25% maximum occupancy
- · Hair salons and barbershops by appointment only
- Pet grooming by appointment only (curbside pet drop- off and pick-up)

- Car washes exterior car washing allowed
- Recreation and outdoor with guidelines
- Other health care providers who attest to specific public health/safety standards can provide high priority preventative care, pediatric care and treatment for high risk patients
- Retail remote fulfillment and curbside pickup

On June 1st, the following is eligible to reopen:

 Offices in the City of Boston, following applicable guidelines for the rest of the Commonwealth

I cannot stress enough that even though we are beginning to slowly reopen our economy in phases, this pandemic is still not over. It is critical that we all still continue to practice physical distancing, wear a face covering when we go outside & do our part in preventing the spread of COVID-19. I urge everyone to adhere to the guidelines of our public health officials so that we can prevent a surge to our hospitals and protect our frontline healthcare personnel, our essential service workers, our families, our neighbors & each other from the virus.


