Dear neighbors,

As we have discussed over the last several months, and patiently waited for over a year, the light at the end of the tunnel is finally now here. Due to enormous achievements of science, technology and the human race, safe and medically proven vaccines have been made widely available to all. Our COVID-19 cases and deaths have plummeted due to over 3.2 million Massachusetts residents now fully vaccinated. As a result of the successful rollouts in New England region, the state of Massachusetts, and the City of Boston, COVID-19 restrictions in the City have now been lifted. Following CDC guidance, the state's face covering order was also rescinded, and Governor Baker's State of Emergency will end on June 15. Moreover, starting Monday, June 7th, Boston City Hall will be open to the public by appointment on Monday, Tuesday, Thursday and Friday.

Over the course of the last month, my team and I continued to work hard on behalf of our District 2 neighbors, including at many spring clean-up and Love Your Block events. With grilling season and Summer nearly upon us, I hosted a community meeting with Boston Fire Commissioner Dempsey regarding fire safety and what's allowed in the City of Boston. Councilor Flaherty and I held a City Council hearing on problem properties with the Boston Police Department and Inspectional Services due to out-of-control parties and quality of life issues. We're advocating for an increased scale of fines for this rude and inconsiderate behavior, as neighbors know this was an issue prior to the pandemic and will continue even as our economy re-opens. We also recognized Asian American Heritage Month, and honored our AAPI neighbors for their many contributions to our city and country.

In observance of a solemn Memorial Day weekend, we took time to reflect on those that made the Supreme Sacrifice in service to our country and honored our Gold Star families as well. Their bravery and sacrifice for our nation, and the cause of freedom throughout the world, shall never be forgotten. We honored their memory at a number of events in District 2, including at the MA Fallen Heroes Memorial in the South Boston Waterfront, Medal of Honor Park and the South Boston Vietnam Veterans Memorial, and the Puerto Rican Veterans Memorial in the South End, to name a few.


# In the Community

Statement from City Councilor Ed Flynn on President Biden's Memorandum Condemning and Combating Racism and Xenophobia Against Asian Americans and Pacific Islanders

I'm pleased to see that President Joe Biden has issued a memo condemning the increased anti-AAPI sentiments during the COVID-19 pandemic. I'm also glad that President Biden is directing federal agencies to lade steps to combat the meism, discrimination, and xenophobia faced by our AAPI residents. As the Boston City Councilor for District 2, 1 represent the largest Chinese community in Boston, which includes Chinatown, the South End, Bay Village, Back Bay, and South Boston I know that the Asian American community is a vibrant and resilient community that deserves to be treated with dignity and respect. Yet this community has faced increased levels of hate and discrimination since the beginning of the pandemic. So it is important that we address the issue of anti-AAPI sentiments at the federal, state, and local levels.

As an elected official, I've focused on language access and providing accurate and updated medical information to my residents on the coronavins in English, Chinese, and Spanish, I have introduced a number of resolutions that were adopted at the Boston City Council in support of our AAPI communities during the pandemic. Thave also spoken out about the increase of anti-AAPI racism and the need to combat such discrimination, including for our students at Boston Public Schools. I will continue working with my constituents, colleagues, city officials and AAPI community organizations to stand up against discrimination, and support our community with empathy, respect and dignity.

Recently, I joined South Boston residents, Boston Police (C-6) Captain Boyle, Representative David Biele, Eversource and Boston Harbor Now for a meeting to discuss the recent



destruction of property at the site of a proposed park on East 1st and K St. (Harborwalk). This vandalism will not be tolerated!

Thank you Boston Fire Department Commissioner Dempsey for participating in our recent meeting about fire prevention and safety. We had an informative discussion, including a Q & A with residents about this critical public safety issue. Fire safety and prevention is everyone's responsibility!





Last weekend, Kristen and I enjoyed attending the dedication and blessing of the Sisters Garden of Prayer and Peace at St. Monica Parish in South Boston. Thank you to the parish community and The Good Samaritan Ministry at Monica's Kitchen for this beautiful garden to benefit the community.
