Dear neighbors,

I hope you and your family are doing well as we head into the fall season.

At the City Council, I recently held a hearing regarding the safety of construction sites due to a recent tragedy and other events in Boston. I authored and passed a resolution celebrating the 10th anniversary of the repeal of "Don't ask, Don't tell". In addition, I am also holding a hearing this week on issues of pest control and illegal dumping due to reports of both increased rodent activity and the illegal disposing of trash at improper locations during the pandemic.

In the community, my team and I continue to focus on improving pedestrian and traffic safety for our constituents. In particular, we have been working with my fellow South Boston Elected Officials, neighbors and the Boston Transportation Department (BTD) on a number of areas recently; including a "No Left Turn" during peak commute times down at Day Blvd & N St, as well

the intersection of N Street and East Broadway, the site of yet another tragic crash in our community. I want to thank BTD for beginning their work on yellow flex posts and paint to widen the median, as well as painting "SCHOOL" in the road in both directions, to help create safer conditions for pedestrians to cross.

I continue to hold meetings each and every day with my neighbors and constituents, local civic groups and community organizations, City of Boston departments, my fellow elected officials, and local businesses to help address public safety and quality of life issues in District 2. Finally, I want to again encourage my neighbors and all residents to get vaccinated against COVID-19. If you have not done so yet, our local, state, and federal public health officials and medical experts have all stated that the vaccines remain the strongest defense against the pandemic and path to return to normal, everyday life. <u>You can find vaccination sites in Boston here.</u>

COVID-19 Relief: \$1 million to support families not eligible for direct federal COVID-19 relief

The City of Boston Equity and Inclusion Cabinet and the Mayor's Office for Immigrant Advancement are awarding \$1 million dollars to the Massachusetts

Immigrant Collaborative (MIC) to support Boston residents who were not eligible for federal COVID-19 relief benefits. MIC will distribute the funds as cash assistance to families in need, regardless of immigration status. MIC will evaluate applications based on Boston residency, household income, access to direct federal COVID-19 relief benefits, and financial need. Cash aid will be given in proportion to the applicant's economic situation. Eligible Boston households can apply for up to \$1,000 in cash aid until funding is exhausted. Hearing regarding the safety of constructions sites in the City of Boston

In recent years, the City of Boston has been experiencing an unprecedented building boom, with large scale construction sites in various neighborhoods, and there are unfortunately a number of accidents that occurred on construction sites, including one tragic incident on High Street this year. Thank you to co-sponsors Councilor Breadon and Councilor Flaherty for their partnership on this issue, and to Councilor Mejia for chairing this hearing. Thank you also to the City's Inspectional Services Department and Boston Police Department for being in the hearing, as well as to the Carpenters' Union for providing testimony.


