Dear Neighbors,

I hope you and your families are staying safe and well during this Christmas and holiday season.

As 2021 draws to a close, I am writing to provide you with a summary of the key areas of our work at the City Council this year: public health & vaccinations, pedestrian & public safety, housing & development, environment & resiliency, civil rights, and quality of life issues.

With a new surge of COVID-19 cases and the Omicron variant quickly becoming the dominant strain in the country, my team and I are working closely with Mayor Wu, Public Health officials, local nonprofits and community partners to continue our efforts to encourage people to get vaccinated and to get their boosters to combat the virus. With holiday gatherings taking place soon, it is critical that everyone gets vaccinated, boosted, and rapid tested if possible before seeing family and loved ones. We know that vaccines are currently the most effective way of providing protection against COVID-19 and preventing serious complications, hospitalizations, and death. We must continue to adhere to the latest public health guidelines from the medical community, and do our utmost to protect our families, our seniors, and our most vulnerable. We have to work together as a City to do our part so that we do not overwhelm our first responders and healthcare providers during this wave.

At the City Council this month, I held a hearing on digital equity with Councilors Mejia and Bok; a hearing regarding electrical vehicle (EV) infrastructure and electrifying the City's vehicle fleet with Councilor O'Malley; and co-sponsored a hearing regarding workforce development opportunities in biotechnology and life sciences with Councilors Baker, Bok, and Breadon. I will continue to work on bridging the digital divide for our low income neighbors, communities of color, immigrants and our seniors; work with the City on expanding new EV infrastructure; and ensure that we connect our schools and young people to job opportunities, internships, and educational resources in the biotechnology and life sciences industry to equip them for jobs of both today and tomorrow.

We have seen Boston's leadership transition a few times this year as we continue to battle COVID-19 and recover from its impact on our economy and livelihoods. We would like to thank Secretary Marty Walsh, Mayor Kim Janey, and their teams for leading our City through unprecedented and challenging circumstances. We congratulate Mayor Wu on her historic victory and will continue to work closely with her administration on our efforts to tackle COVID-19 and address quality of life issues in our neighborhoods.

Thank you very much for your support. I wish you and your family a Merry Christmas, and a safe and happy holiday season.

COVID-19 latest

<u>Please note face masks continue to be required in all indoor public settings in</u> <u>the City of Boston.</u> This requires everyone over the age of two to wear a mask or face covering at indoor public places such as businesses, clubs, restaurants and bars, retail outlets, performance venues, gyms, event spaces and municipal buildings.

Vaccine & Booster Update

Please note children ages 5 to 17 are now eligible to get the Pfizer vaccine. Boston Public Health Commission and Boston Public Schools are providing FREE vaccine clinics to anyone ages 5 and above. You can check upcoming vaccine clinics on their calendar here: <u>http://bostonpublicschools.org/vaccines</u>

People ages 18 and older who are unvaccinated can get any vaccine. Boosters are also available for anyone ages 18 and above who have received the 2-dose Pfizer or Moderna for at least 6 months, or the single-dose J&J for at least 2 months. B Together

In an effort to address rising COVID-19 cases and encourage vaccination, Mayor Wu announced that starting on January 15th, 2022, individuals will be required to show proof of vaccination against COVID-19 in order to enter certain indoor spaces in Boston. This includes indoor dining, including bars and nightclubs; indoor entertainment, recreational and event venues, including movie theaters, music or concert venues; indoor gyms and fitness centers, including commercial gyms and fitness centers and studios. Please note employees working in these spaces will also be required to be vaccinated. Please find below the timeline to show proof of vaccination:

- January 15: People age 12+ must show proof of one dose of vaccine
- **February 15**: People age 12+ must show proof of full vaccination
- March 1: Children age 5-11 must show proof of one dose of vaccine
- **May 1**: People age 5+ must show proof of full vaccination

COVID-19 Home Testing Kits

With COVID-19 cases on the rise again, the Boston Public Health Commission (BPHC) is offering free rapid at-home test kits to Boston residents at designated community sites across the city. Residents can drop by a pickup site and take up to one kit (which includes two tests) for each member of their household per visit. Supplies are first-come, first-served, and due to high demand, BPHC is currently working to send additional kits to sites. We have been informed that supplies will be delivered to the sites every day up until Thursday, December 23rd, and will resume the Monday after Christmas while supplies last. Residents are encouraged to call before stopping by a location.
