# Dear neighbors,

Let us honor our African American neighbors and communities, and celebrate the remarkable achievements and sacrifices they have made for our country.

# **COVID-19 latest**

Please note effective January 15th, individuals are required to show proof of vaccination against COVID-19 to enter certain indoor spaces in Boston. Face masks also continue to be required in all indoor public settings in the City of Boston. This requires everyone over the age of two to wear a mask or face covering at indoor public places such as businesses, clubs, restaurants and bars, retail outlets, performance venues, gyms, event spaces and municipal buildings.

Please note children ages 5 to 17 are now eligible to get the Pfizer vaccine. COVID-19 boosters are now also available for people ages 16 and above. 16 & 17-year-olds are eligible for the Pfizer booster only.

Boston Public Health Commission and Boston Public Schools are providing FREE vaccine clinics to anyone ages 5+. You can check upcoming vaccine clinics on their calendar here: <a href="http://bostonpublicschools.org/vaccines">http://bostonpublicschools.org/vaccines</a>

People who are 18 and older can get any vaccine. Eligible people age 18 and older can get any booster (Pfizer, Moderna and J&J).
