Dear neighbors,

March was an eventful month, and after a two-year hiatus, it was wonderful to attend Evacuation Day events throughout the City of Boston and celebrate the St. Patrick's Day Parade in-person with neighbors, veterans, military and Gold Star families.

As we brace for another potential wave of COVID-19 cases with a new Omicron sub-variant, the CDC has recommended a second mRNA booster for people over the age of 50 and anyone over the age of 12 with certain immunocompromised conditions who received the initial booster at least 4 months ago. Please note young people ages 12-17 can only get a Pfizer booster. I continue to encourage everyone to get vaccinated and to get boosted. Vaccines remain the most effective way to combat COVID-19 and prevent serious complications, hospitalizations and death.

With the budget process beginning soon, please feel free to tune into our City Council Hearings and provide any public or written testimony on what you would like to advocate for and see improved for your neighborhood and community.

COVID-19 Vaccine & Booster Update

The FDA has approved the use of a second COVID-19 booster dose for people at higher risk of infection. All people over the age of 50, and all immunocompromised people over the age of 12 are now eligible to receive a second booster dose, provided that it has been at least 4 months since their last dose of booster.

Children ages 5 to 17 are now eligible to get the COVID-19 vaccine. COVID-19 boosters are now available for people ages 12 and above. Young people between 12 and 17 years of age are eligible for the Pfizer booster only. Boston Public Health Commission and Boston Public Schools are providing FREE vaccine clinics to anyone ages 5+. People who are 18 and older can get any vaccine. Eligible people age 18 and older can get any booster (Pfizer, Moderna and J&J). If you are unsure whether you are eligible for a booster or which booster to get, the State website provides more information here: <u>https://www.mass.gov/covid-19-vaccine</u>


