[Please note face masks continue to be required in all indoor public settings in the City of Boston.](#) This requires everyone over the age of two to wear a mask or face covering at indoor public places such as businesses, clubs, restaurants and bars, retail outlets, performance venues, gyms, event spaces and municipal buildings.

Vaccine & Booster Update

Children ages 5 to 17 are now able to get the Pfizer vaccine. People who are 18 and older can get any vaccine. Eligible people age 18 and older can get any booster (Pfizer, Moderna and J&J). COVID-19 Relief: \$1 million to support families not eligible for direct federal COVID-19 relief

The City of Boston Equity and Inclusion Cabinet and the Mayor's Office for Immigrant Advancement are awarding \$1 million dollars to the Massachusetts Immigrant Collaborative (MIC) to support Boston residents who were not eligible for federal COVID-19 relief benefits. MIC will distribute the funds as cash assistance to families in need, regardless of immigration status. MIC will evaluate applications based on Boston residency, household income, access to direct federal COVID-19 relief benefits, and financial need. Cash aid will be given in proportion to the applicant's economic situation. Eligible Boston households can apply for up to \$1,000 in cash aid until funding is exhausted. 

Council Hearings and Resolutions



Order for a hearing to discuss investments in electric vehicle charging infrastructure & electrifying the city of Boston's vehicle fleet

I was proud to partner with Councilor Matt O'Malley in calling for a hearing to discuss Electrical Vehicle (EV) charging infrastructure, as well as electrifying the City of Boston's vehicle fleet. After a landmark legislation on BERDO 2.0, our transportation sector will be key in reducing pollution and carbon emissions. With federal legislation, and funding aimed at both EV charging infrastructure and tax credits to incentivize consumers, as well as the major car companies spending billions to go electric in the coming decade, it is critical to discuss Boston's vehicle fleet and building out our infrastructure -- not only at new construction developments, but also at municipal facilities, schools, libraries, and parking lots.

Resolution in support of H. 3115 "An Act Ensuring Equitable Representation In The Commonwealth"

I was proud to sponsor and pass a resolution with Councilor Michelle Wu in support of a bill by State Representative Tackey Chan to ensure accurate and equitable data collection. This allows us to better understand the needs of different communities and make them more visible, especially at a time when there is a rise in hate crimes.

Hearings Recently Held

Hearing to discuss pest control and illegal dumping in the city of Boston

I was proud to hold a Council hearing with Councilor Liz Breadon and Councilor Lydia Edwards on the issue of pest control and illegal dumping. During the pandemic, our offices received increased reports of pest and rodent activity from neighbors, and other related quality of life issues. We spoke with officials from Public Works, Inspectional Services, and community advocates about these issues, and emphasized the importance of working with constituents to enforce fines on illegal dumping. We discussed the need to include rodent mitigation as part of the development process and talked about the need for education and outreach to residents on how to properly dispose of trash and prevent rodent activities.

Hearing on Preservation Restriction Agreement for Historic Property in Bay Village

I recently chaired a hearing on the confirmation of a preservation restriction agreement between a property in Bay Village and Historic New England. This is an agreement that outlines what the property can and cannot do in order to preserve its historic elements. This property was constructed in the 1840s, and this agreement will preserve its exterior, staircase, interior details, fireplace, and other features. This is a great way to preserve some of our city's historic properties, and the agreement was approved by the City Council.


I was honored to attend the English for New Bostonians' Raising Our Voices reception at Northeastern University last week. We celebrated our
